

Terms & Conditions of Your Stay

Adelaide Showground and Adelaide Showground Caravan Park are owned and managed by the Royal Agricultural & Horticultural Society of SA Inc. (RA&HS) and will be collectively referred to as "the Venue"

Persons entering the Venue are bound by these Terms & Conditions and do so at their own risk. As you proceed around the Venue, take care to observe and follow all signage and any instructions that you may be given. Take special care at all times to protect yourself and others against any loss or injury.

Adelaide Showground Caravan Park is an exciting new inner-city space for caravanners to enjoy Adelaide. A pleasurable stay for all guests requires mutual respect and observance of the following reasonable rules.

Access

Guests and visitors enter the Venue at their own risk. By entering the Venue, guests and visitors agree to indemnify RA&HS against any loss or liability, cost, expense or damages arising from or in relation to the entry either by person, vehicle or otherwise. Initial entry to the Adelaide Showground Caravan Park will be via a guest specific code which will be sent no later than 24 hours prior to your proposed stay. This code will provide guests with entry and exit to and from the Park throughout the duration of their confirmed stay.

Arrival

Your allocated site will be available between 2pm and 11 pm on the first day of your confirmed booking.

Departure

The site must be vacated by 11am on the day of departure. Guests should ensure that the site is left clear of litter and personal belongings. If in the opinion of RA&HS, cleaning required after a guest's departure is excessive, the cost of cleaning will be the responsibility of the guest.

Respectful stay

Guests are asked to be respectful of others during their stay. Noise and amplified music should be ceased no later than 10pm each evening.

RA&HS reserves the right to refuse entry or immediately evict any guest, visitor or member of the public from the Park at its absolute discretion, including but not limited to, anti-social behavior, causing damage, disturbing other guests, using unacceptable language or otherwise breaking Park Terms & Conditions.

Adelaide Showground events

Adelaide Showground is a precinct which operates as an event venue throughout the year. Guests must adhere to any pedestrian or vehicle restrictions which may apply from time to time to accommodate the presentation of events. Guests should abide by any instructions given by RA&HS staff.

All roads within the Venue are public roads and subject to all relevant legislation including vehicle registration, roadworthiness and road rules. The speed limit on all roads is 10kph unless otherwise communicated. Guests must always abide by this speed limit.

Alcohol and illicit drugs

Alcohol may be consumed on your allocated site and in the Camp Kitchen and BBQ areas only. Drunken or disorderly behavior, persons supplying alcohol to minors and/or possession of illicit drugs will be reported to the Police.

Camp Fire

There is a central Camp Fire for general use. Visitors must comply with the Camp Fire Rules displayed adjacent to the Camp Fire.

COVID-19 Coronavirus

Visitors must abide by any special instructions which RA&HS issue in respect to managing the impact of COVID-19.

Cycling

Cycling is permitted throughout the Adelaide Showground. All road rules apply including helmets being worn as required by law.

Damages or Losses

Guests shall be liable for any loss or damage caused by them to the Venue infrastructure including but not limited to Amenity blocks and BBQ facilities, site power poles on the caravan site or entry and exit boom gates.

Fires

Visitors may use their own individual fires, only approved fire pits can be used including wood and charcoal fire pits, camp ovens and grills. All electric and gas appliances must be compliant and in good working order.

The following rules must be observed:

- 1) Use of fires is prohibited on days of fire ban or when the daily forecast exceeds 35 degrees visitors will be notified on these days.
- 2) Fires can only be used between the months of May to September.
- 3) Fires must be self-contained in professionally produced equipment, where the fire is at least 30cms above ground level.
- 4) Fires should not be used within enclosed spaces, must not be placed on grassed areas or roadways, and be always attended by an adult .
- 5) A hose or bucket of water must be kept nearby.
- 6) All fires must be extinguished by 10pm.

Kitchen facilities

Food preparation and cooking facilities are provided within the Camp Kitchen. These facilities will be available for use from 6.30am to 10pm each day and will be regularly serviced and cleaned. Guests are asked to keep the facilities clean and tidy in respect of other guests in the Park.

Laundry

Laundry facilities are available within the Camp Kitchen facilities. Erection of temporary clothes lines outside the boundary of your site is prohibited.

Parking

Caravans must be parked with drawbars facing the roadway, for fire safety reasons. Sites allow for the towing vehicle to remain on site adjacent to the caravan. Adelaide Showground has significant public car parks available should guests require parking for additional vehicles. Your caravan/motorhome and personal belongings should always be kept within your site perimeter.

Personal Belongings

Adelaide Showground Caravan Park is always staffed and secured by a network of closed-circuit television cameras. However, guests should be vigilant in locking their vehicles and caravans and avoid leaving personal belongings visible to other caravan park users. RA&HS takes no responsibility for the loss or damage of any personal item.

Pets

Adelaide Showground Caravan Park welcomes pets. Guests are responsible for their pet and must abide by the Adelaide Showground Caravan Park Pet Policy.

Photography, Filming or Recording:

It is not our intention for amateur photographers to be restricted from taking photos or recording around the Showground, providing that:

- 1) Cameras, including mobile phones with recording capabilities, must not be used in areas such as toilets, parenting/shower and change rooms.
- 2) The photographer is not causing annoyance or inconvenience to other patrons.
- 3) The subject of the photo/recording is not one detailed in the Summary Offences Act 1953.
- 4) The subjects have given their consent (if under 18 then their parent's/guardian's consent).
- 5) The photos/recordings are not to be sold for commercial gain.

Professional Photographers must seek prior approval from the RA&HS.

Restricted items

The following restricted or prohibited items are not permitted into the Showground and are subject to immediate confiscation and includes items listed by the South Australia Police;

- 1) Illicit drugs or drug paraphernalia;
- 2) Laser Pointers;
- 3) Prohibited weapons and explosives;
- 4) Flares or Fireworks;
- 5) Knives or other dangerous weapons including potential missiles;
- 6) Flags over 1m x 1m in size;

and any other items as determined by the RA&HS management that may cause offence, injury or public nuisance.

Rubbish

The Venue operates a three-bin system for collection and disposal of waste. Guests should place their rubbish in the appropriate bin – green bin for organics and compostable waste, yellow bin for recyclable waste and red bin for waste to be sent to landfill.

Bottles and cans of certain specification in South Australia are subject to a refundable Container Deposit. Bins specific to the collection of these containers are placed near each Camp Kitchen. A portion of proceeds of the refund may be directed the Show Society Foundation.

Smoking

Smoking is prohibited within 10 metres of, or in the Camp Kitchen facilities and within 10 metres of, or inside any other building at the Adelaide Showground.

Sullage

A Dump Point is situated at the south western corner of the Adelaide Showground Caravan Park. Guests may use this facility as part of their site fee.

Toilet & Shower facilities

Toilet and shower facilities are available in the Amenity blocks and will be regularly serviced and cleaned.

Visitors

Visitors are welcome at the Adelaide Showground Caravan Park. Visitors should park in the Adelaide Showground car parks on Leader Street as no parking is available for visitors inside the caravan park. Guests are responsible for the behaviour of their visitors while attending the caravan park.

Vehicle Maintenance

No mechanical repairs to vehicles are to take place in the Park, including oil changes.

General Conditions

The following conditions apply to those entering the Showground;

- Persons entering the Venue agree to indemnify the RA&HS against any loss or liability, cost, expense or damages arising from or in relation to the entry either by person, vehicle or otherwise;
- Persons causing a disturbance or refusing to comply with requests from the RA&HS, including displaying racial, religious or politically discriminatory material, language or gestures deemed indecent or offensive, will be ejected from the Venue without refund;
- RA&HS may refuse admission to or eject persons from the Venue at its sole discretion;
- RA&HS and South Australia Police conduct surveillance on the Venue and have access to security footage. A person entering the Venue may be photographed, filmed, taped and/or subjected to monitoring by closed circuit television (CCTV).It is deemed that a person by entering the Venue consents to the RA&HS or third parties appointed by the RA&HS photographing, filming or recording them. The RA&HS or third parties appointed by the RA&HS can broadcast, publish, licence and use any photographs, film, recordings or images without compensation. The RA&HS, third parties and anyone acquiring from them a right to use the material are not liable to the subject for its use in any way;
- Entry to the Venue does not guarantee automatic entry to events and activities at the Venue during the period of entry;
- Parking is restricted to areas as designated by the RA&HS from time to time and vehicles must not block emergency egress doors or emergency vehicle access roads and are to give way to emergency vehicles;
- All hazards, incidents or emergencies are to be immediately reported to RA&HS on 0419 185 312; and
- Persons must obey all signs, notices and directions given by the RA&HS.
- Persons gaining unauthorised access to the Venue may be liable for prosecution;
- RA&HS is not liable, nor does it accept any responsibility for any loss or damage whatsoever to any person or property or the death of or injury suffered to any person or animal whilst at the Venue.

Variation of Terms & Conditions

These Terms & Conditions may be varied without notice, at the sole discretion of the RA&HS.
